The SEOC originates RMTs through a combination of CAP via IPAWS and OEAS fiber via OET embedded digital stream, and firewalled G-Net audio codecs to LP stations with legacy Over-TheAir transmission to the 12 Operational Areas across the state. WNCI and WBNS-FM are the lead stations for OTA distribution to all Radio, TV, and Cable operators - statewide.

The BDR is Celebrating Our 15th Year Of Dedicated Support For Broadcaster

1/23/24 – The FCC had adopted new rules that voice, cable., and Internet providers report their status each day the DIRS (Disaster Information Reporting System) is activated. Broadcasters are currently exempt, but the Commission is considering an NPRM (PS Docket No. 21-346) to require the reports which are now voluntary (only 1/5 to 1/3 of stations in affected areas usually participate). The NAB suggests this is not going to work easily, especially for small stations – or any place where the Internet goes down.

1/22/24 – Police in Paris Texas <u>arrested a pair of copper thieves</u> who caused some \$500k of damage to the KITX (Hugo, OK) tower in order to get about \$100 worth of copper.

This is just another sad example of what many stations know all too well: the reward for the crooks is so small, compared to the damage caused.

1/11/24 – We are now down to a dozen weeks before NAB 2024 hits the stage in Las Vegas. The <u>2024 NAB Show registration is now open</u>. If you are thinking of going, you can get a free floor pass now: Inovonics shares this Free Floor Pass code: NS5268 and Nautel is using NS9564. Also, do not forget the <u>Nautel</u> User Group (NUG) on Sunday at NAB.

1/9/24 – The FCC relased it quarterly total of broadcast stations that are licensed. There were basically just a literal handful of changes, although the erosion, especially on AM continues: Townsware has taken five stations dark, and turning in the license for at least three of them.

1/8/24 – The January FCC Open Meeting (on 1/25) current has the DIRS (Disaster Information Reporting System) on the agenda. The FCC is said to be working toward making participation (reporting disaster outages and other operational issues) to be mandatory. While that may not be settled this month, and NPRM is expected to be set out on the matter.

1/8/24 – Accounting for inflation, the FCC's maximum fine for obscene, indecent, or profane broadcasts is now up to \$495,500 for each violation – or per day for continuing violations. The new maximum is \$4,573,840. Plus legal fees.

Pirate fines also went up: unlicensed operation can be fined \$61,238 a day, up to a maximum of \$612,238. For most other rules, the daily fine is \$61,238, but tops out at only \$612,238. Plus legal fees

1/29/24 – Starting April 14, 2024, EAS users will install a new certificate to receive IPAWS CAP alerts. Without the update, the weekly tests and alerts sent through the FEMA system will not be received by stations. This is a free update for all U.S. DASDEC and One-Net users, and the new certificate is fully functional right now, so you are advised to replace the current certificate to ensure the required message authentication continues to operate correctly.

1/25/24 – The FCC has issued a report on the status of its efforts to increase personnel and specialized equipment in order to locate more illegal radio broadcasters, finding the properties where they originate and warning property owners under the PIRATE Act (Preventing Illegal Radio Abuse Through Enforcement). The EB has identified a number of illegal stations, some operating for years

The FCC's efforts under The PIRATE Act to locate and city pirate broadcasters recently swept in the area around Miami, Florida, where more warnings to landlords of fines of over \$2 million were issued. **Five personal citations (totalling over \$3.5 million) were issued to operators** who were said to have been broadcasting for years without a license. Most eye-popping: **the maximum – \$2,391,097 – issued to Fabrice Polynice**, who had been cited at least twice before in the past 10 years.

1/19/24 – **Section 312** – Not every station can operate from a tree. But it is possible. On the other hand, "moving to an adjacent tree" without permission – coupled with some long spans of being silen – brought an "D" to KQCF(FM), Chiloquin OR, <u>now</u> **DKQCF(FM)**.

1/18/24 – 73.1212, 73.1943 – In one of the argest fines leveled at a broadcast company, the FCC issued a Consent Decree with Townsquare Media for \$500k. The issue had to do with a pair of Idaho stations (KLIX and KIDO) the Commission was investigating regarding on-air sponsor identification and the Political File uploads required by the Rules. The Consent Decree closes the case.

1/16/24 – The US Court of Appeals denied the petition from WEKC to reinstate the license deleted last February (2/7/23, below).

1/16/24 –73.2080, 73.3526 – FCC has fined Cumulus Licensing LLC for violations of EEO rules at five former stations in Georgia. The Forfeiture Order is for \$26k. The EB noted that the fine was more than doubled from the base – \$12k – due to previous similar violations (2008, 2017, etc) by Cumulus holdings. The exacerbating point: the report was nine months late.

The Society of Broadcast Engineers celebrates its 60th anniversary in 2024. To mark the occasion, the SBE is announcing special projects and events throughout the year. The first relates to the SBE Program of Certification, which is the benchmark of broadcast and multimedia technology skill evaluation.

Called the Diamond Project in recognition of the SBE's 60th anniversary, individuals who have held SBE Certification but let it expire can restore their SBE-Certified status without taking an SBE Certification exam. The Diamond Project runs through the calendar year 2024 (January 1, 2024 to December 31, 2024). Individuals who allowed their SBE Certification to expire prior to January 1, 2023, qualify for this project. Applicants are required to complete the Diamond application (found on the SBE website under sbe.org/diamondproject) and provide it with either a resume or a letter to the certification committee stating what he/she has done in broadcast engineering since the applicant's SBE certification expired.

All SBE Certifications are included in the reinstatement program. There are two price points. All SBE Certifications except Certified Professional Broadcast Engineer (CPBE) can be reinstated for \$125 for each level of certification. Those who held CPBE that expired prior to January 1, 2023, may either reinstate at the senior level certification held prior to the CPBE at the rate above, or they may choose to reinstate the CPBE for \$200. All these costs are for current SBE members. Non-member fees apply for those who are not currently SBE members, which is an additional \$85 for traditional membership or \$175 for SBE MemberPlus.

SBE Certification must be renewed every five years. This is to ensure those who are SBE Certified stay current with technology. If a certification is allowed to expire, the individual must normally take the SBE Certification exam again to obtain the credential.

"The SBE Program of Certification, established in 1975, continues to grow and evolve to meet the changing needs of technical professionals and stay current with technology," said Ralph Hogan, CPBE, ATSC3, DRB, CBNE, chair of the SBE Certification Committee. "Sometimes people let their certification lapse for a variety of reasons. This allows them to become SBE-Certified again."

"SBE Certification is the widely regarded as the benchmark of technical proficiency in the broadcast community," said SBE President Ted Hand, CPBE, 8-VSB, AMD, ATSC3, DRB. "The Diamond Project is an ideal way to reobtain SBE Certification and to further one's career."
